With the advent of Islam, no other religion is the acceptance of God's holy nature, and therefore the person who kills the Divine faith, committed an unforgivable sin, and severe punishment awaits him. End, with the advent of Islam, all other religions must stop their rituals, and adherence to Islam's across the board. 2. Apostasy and its variants

Great jurists about apostates, which is considered to originate in the Qur'an [Al-Baqarah 217 - Al Imran 85], no specific comment, however, in terms of Expressions, or about the types of apostasy, national and natural, disagree, many jurists, when expressed in a variety of apostasy, writing, or apostasy or Indigenous or non-indigenous, but some scholars like the Sahebe Javaher, the expression of a variety of apostasy, heresy have used more explicit about the two types, and clearly said, the two species is heresy, apostasy innate apostasy. (Najafi, No data., vol 41, p 629) However, different interpretations of the jurists on national apostate, like Allameh in Izaholfavaed writes, the apostates, have heresy is innate, being murdered, and otherwise is invited to repent. (Allama Hilli, 2010, vol 4, pp. 550-548) Innate Apostate is someone who, at the time of his conception, or after its conception until reaching the age of his parents, or both have been Muslims he was a prepubescent consequential Muslims, and after reaching puberty, leaving Islam is a national apostate is someone who, since signing his Of seed until reaching puberty, none of his parents, not Muslim, and his post- puberty Muslims, and later to have abandoned Islam. 3. Of apostasy

A) works apostasy in the Qur'an

In one case, merely confusing to those apostates were introduced, such as Surah Al-Baqarah verse 108: "Do you want your Prophet, as do the absurd claim that Moses did before? [And with that excuse, refused faith] who accepts disbelief instead of faith, reason and nature has strayed from the straight path."

The Quran, on the other punishment in this world and hereafter, to their promises, have sworn to God, that in the absence of the Prophet, who said the wrong words, while certainly say blasphemous words, and the Surrender of infidels have been dangerous to have decided that they are not, they just take the revenge, that God and His grace to them and their wines were needless, however, if they repent, it is better for them., and if they turn back, Allah in this world and hereafter, to the punishment of a painful punishment, and the earth are not the sponsor, nor any helper. (Tobe, Verse 74)

B) Works of apostasy in Islamic law and Jurisprudence Some of the most negative effects of apostasy are:

3.2. Foreclosures

Innate apostasy, led to the expropriation of private Property is, of course, it's here, it 's kind of expropriation, which alienated him from Properties know, it means that he assumes a dead man in front of his property, so, Property an apostate, must be divided among the heirs Muslims, and if not The heirs to judge Islam, the transition is, of course, the national apostate, before rejecting the offer of repentance, and also women, apostates, whether innate or nationalization, expropriation is not. The author, a scrutiny of the books of the jurists, death is divided into three categories: a) the actual death b) the presumed death (absent missing), c) a death sentence, it seems, by an apostate, apostasy is Denied tenure the property, and before being executed, and if the heirs of his property, is divided among the heirs, and if no heirs, his property is the legal governing authority, and also the rules of Juridical [Ruling of the Crown has no guardian - and the legacy of the ruling is not the inheritor of his, Were entitled theory is confirmed.

However, many scholars, the insults and abuse, raises an issue separate from apostasy, which is its own judgment, and do not heresy, even though it is alleged that, between stripping and apostasy, there is no difference. Some scholars, as have been the one Almighty God, to insult the Prophet or the Imams apostates, the death of the jurisprudential consensus, and consensus Both swear by it, this implies in the hadith, whoever intentionally Imam and leader, who is from Allah, to deny him, and religion and antipathy Chew, an apostate from Islam. (Horr Ameli, 2012, vol 18, p 544)

Imam who accepted the gut, but then tries to deny it, and include an Imam who did, did not believe. (Horr Ameli, page 356, Vol 18, 2012; Kolayni, no data., vol 2, p 388)

Also, in insults Hazrat Fatima (SA), and apply this as an insult, and his insults to insult the Prophet returned.

Islamic criminal law, insulting the Prophet talks about God's final season as a change in the new law, the Articles 262 and 263. Expression has also suspended the debate on the tenth season of the year 513, or, as insulting religious sanctities, is presented. It seems, everyone holy prophet of Islam, and all the great prophets of God, to insult, or to Fling, Insulting the Prophet, and sentenced to be executed. The amendment to Article 262, stating that, Fling any of the infallible Prophet (SAW), the prophet Saab sentence, and also had the lyrics insulting the Prophet (SAW) is a prophet in the sub- decree, but in the Article 513 BC. M.. A.., Suspended the legislator in question, regardless of insulting the Imams and Hazrat Zahra (SA), subject to Insulting the Prophet and the death sentence is known. Seems to conflict resolution and the amendment of Article 262 and 513, it is obvious, but the result is that, by keeping an eye on the logical interpretation of the rule of jurisprudence, "Combining an understanding of the possible first subtraction", and that the best word insult Fling surprising Fling insult to Zahra' infallible Imams and the Prophet (SA), Insulting the Prophet and the death sentence is true.

4. Conclusions

- The legal culture, our religion, which has its basis in its place, the method of rational understanding and dialogue style, away from coercion, in the realm of belief is based on the love of observing certain social interests, and given that, some said such acts of apostasy, and the consequences of fragile social and irreversible, has been sentenced to proceed to the legislation. Blood' problem and narrow interpretation of criminal law, presumption of innocence is confirmed.
- The new Penal Code, concerning apostasy, there is no clear wording of the question of God, and criminalization is not the only legislator to Insulting the Prophet, the alternative of apostasy has pointed out, the only legislator in Article 220 of the Act, stating had " the part that is not mentioned in the law, according to article 167 of the Iranian constitution."
- And noting that apostasy is a part of God, and the judge will refer the law.

 Famous fatwa Imami scholars, confirm that the blood Abandoned innate apostate and should be killed, and his repentance is not accepted, but the national apostate repents, he is accepted, the new Penal Code, punishable by a discussion of repentance unto barriers is entitled law in Article 114, two points can be derived:
 - A) In all of God's crimes, if convicted of the offense proved to repent, be annulled.
- B) If the accused, after incriminating confession, the court is at liberty, pardon the offender was asked by the head of the judiciary of the Supreme Leader, End according to Article 220 of the Penal Code, which is part of the apostasy of God, and Article 114 the rule, she lies, including all offenses the extent, therefore repent with the terms of Article 114 is binding.

Also be interpreted in favor of the accused is also confirmed in this case, and the rights Elite believe in the principle of legality of crimes and authorized, in turn, refer to the law, the process is not punishment, and seems to repent, the conditions of Article 114 of the Penal Code in order to move toward an interpretation in favor of the defendant, and caution should be compatible Dma'.
